GENERAL INFORMATION

1. At the Market Manager's discretion, a local non-profit/ community organization may be permitted to participate in the Yachats Farmers Market. There will be no charge for this space.
2. The Market allows one (1) space for non-profit/community organization usage per week. Approved applicants will be given space on a first-come basis. Applicants may be assigned additional weeks (upon request) as space permits.
3. To request a free (10' x 10') stall space, the organization must submit an application. Upon review and approval by the Market Manager, a space will be assigned as space permits.
4. Requesting organization must provide all items for their booth. If setting up a canopy, you must provide weights of a minimum of 25 pounds per canopy leg.
5. Organizations may distribute information; solicit donations, give away prizes and sell raffle and/or event tickets. Activities are restricted to the stall space. Please no microphones or electronically enhanced presentations.
6. Organizations **may not** sell any item other than raffle and/or event tickets. If you wish to sell handmade items, you must apply as a craft vendor.
7. Market Rules apply to all community groups and organizations. Please read them before completing and signing this application. The Rules are available on the web site.
